The T9402 is intended for AADvance control and safety system. Its application must follow the approved system architecture, safety lifecycle and project documentation.

- 02 Approved chassis/base and termination assembly
- 03 Slot assignment and module keying
- 04 Field supply, polarity, shields and grounding
- 05 Application configuration and diagnostic coverage
- 06 Site proof-test and change-control requirements

Installation Precautions and Source

Before Installation or Replacement

- Use the site-approved isolation or live-insertion procedure and required PPE.
- Record existing wiring, slot, revision, configuration and diagnostics before removal.
- Inspect connectors and termination hardware; correct damage or contamination before fitting.
- After installation, complete diagnostics, functional testing and required proof-test records.
