Industrial automation, process control, machinery, utilities or robotics installations using the named ABB product family; exact use depends on the approved system design.

## Pre-installation record

| Parameter     | Verified value                                                                         |

| Identity      | Record complete model CI522A 3BSE018283R1 and every revision/suffix from the nameplate |
| Evidence      | Retain the cited manufacturer PDF and site-approved drawings                           |
| Configuration | Back up the approved controller, network or module configuration                       |
| Connections   | Label cables, terminals, module positions and field wiring                             |
| Commissioning | Define a point-by-point or communication verification plan                             |

## 2. Installation and commissioning controls

### Recommended verification sequence

| Parameter     | Verified value                                                             |
|---------------|----------------------------------------------------------------------------|
| 1 - Identify  | Match the full nameplate and physical construction                         |
| 2 - Isolate   | Follow site lockout, electrical-safety and ESD procedures                  |
| 3 - Compare   | Confirm companion hardware, cables, termination and revision compatibility |
| 4 - Install   | Use manufacturer mounting, grounding and environmental requirements        |
| 5 - Configure | Restore only the approved configuration and documented settings            |
| 6 - Test      | Verify communications, diagnostics and every affected process function     |
| 7 - Release   | Record results and obtain the required site authorization                  |

### Model-specific precautions

- Match the complete model, order code, revision and physical construction before installation or replacement.
- Use only the electrical ratings, wiring and environmental limits stated in the applicable ABB document.
- Record the existing configuration and test every affected signal, communication path and safety function before release.
