Pre-Installation Plan

NO.	REQUIRED ACTION
1	Verify the complete 330709-000-050-10-12-05 order code from the physical marking.
2	Use only matched 3300 XL 11 mm Proximity Transducer System probe, cable and Proximitor Sensor components.
3	Record the existing gap voltage and monitor-channel setup before disturbing the loop.
4	Protect the probe tip, coaxial connectors and cable from impact or contamination.
5	Observe the documented bend radius and do not twist the integral or extension cable.

Companion check	Matched probe, extension cable and Proximitor Sensor
Configuration	Configured machinery monitor channel

RELEASE HOLD POINT

Do not disturb the installed device until the exact marking, connections, companion hardware and configured function are documented.

Wiring and Interface Checks

CHECK	MODEL-SPECIFIC REQUIREMENT
Identity	Confirm 330709-000-050-10-12-05 and each dash option.
Matched loop	Confirm every component belongs to 3300 XL 11 mm Proximity Transducer System.
Cable route	Record length, bend path and connector protection.
Target	Verify material, size and side/rear clearances.
Gap	Record as-found and final gap voltage.
Field wiring	Confirm shield, common and monitor-terminal assignment.
Dynamic test	Verify response to a controlled target movement or approved simulator.
Release	Confirm channel OK state, alarms and documented proof test.

CONFIGURATION BOUNDARY

Install 330709-000-050-10-12-05 only with the matched 3300 XL 11 mm Proximity Transducer System components. For probe orders, the probe lead and extension cable must match the selected 5 m or 9 m sensor length. Record the marking, channel, cable route and target before work, then prove gap voltage and dynamic response before release.

Technical Questions to Resolve

QUESTION	ENGINEERING ANSWER
What product family must be matched with 330709-000-050-10-12-05?	Use only components from the documented 3300 XL 11 mm Proximity Transducer System.
Which order-code identity must be recorded for 330709-000-050-10-12-05?	Record the complete code, not only the base series number.
What target condition must be verified before gapping 330709-000-050-10-12-05?	Verify material, surface geometry and the approved measurement location.
What must be preserved before removing 330709-000-050-10-12-05?	Record gap voltage, channel configuration, cable route and connector condition.
