Place the connected powerflex 7000 maintenance service process in the approved maintenance state.
- 3

Isolate applicable power and documented powerflex 7000 control-platform service function field energy before disconnecting conductors.
- 4

Record connector, conductor, address, firmware and software identities before removal.
- 5

Use ESD controls and protect keyed interfaces, exposed contacts and electronic assemblies.

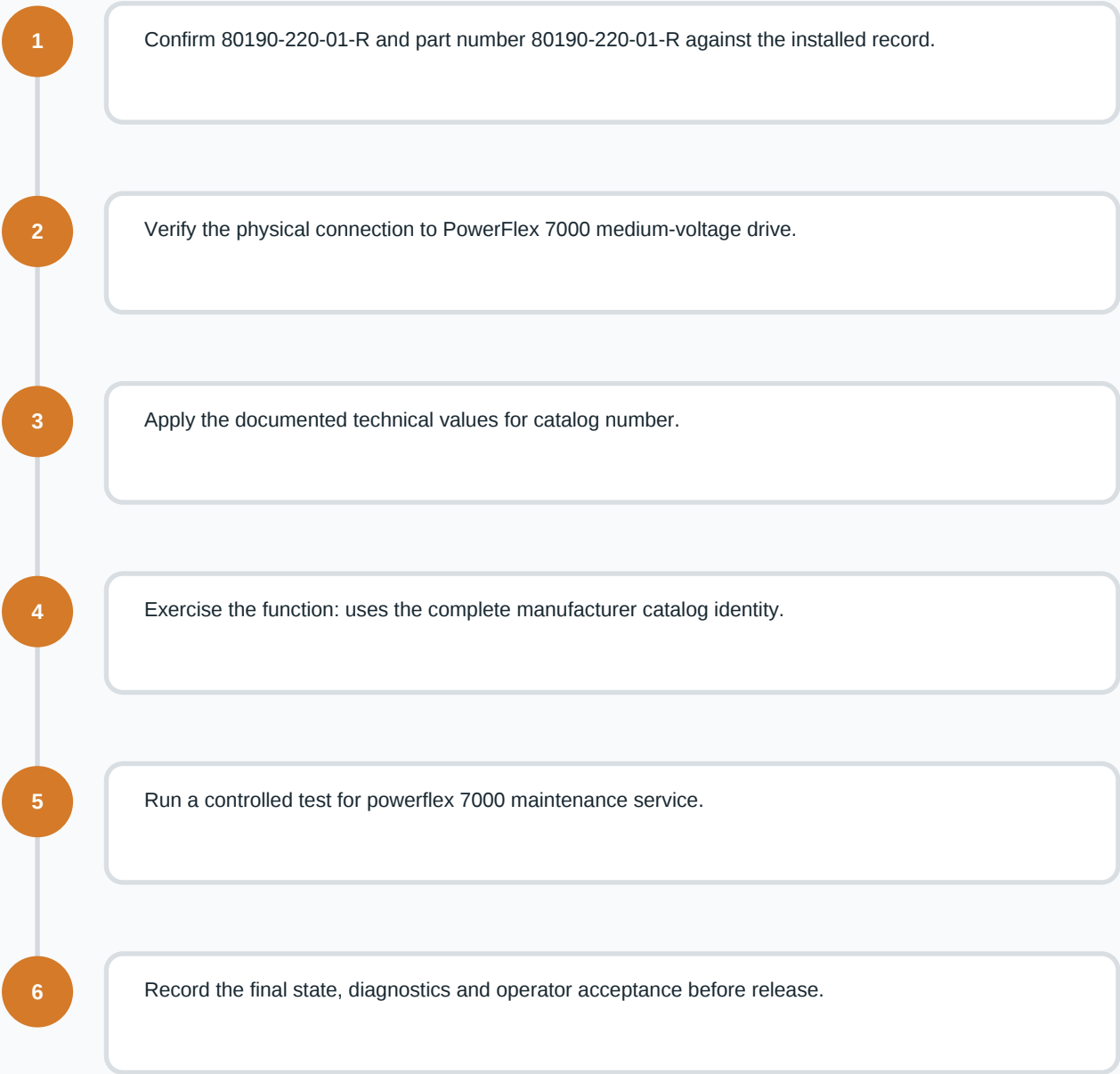
