Match Bently Nevada 330881-28-04-70-03-02 to the documented host and mating interfaces, and record the as-found PROXPAC XL ordering execution, connections, cable route, shielding and configuration. Restore the approved arrangement and verify diagnostics and controlled channel response before release.

- 1 Confirm the documented host, mating components and physical interfaces.
- 2 Restore the approved mounting, wiring, shielding and monitor configuration.
- 3 Review supply, bias, channel and monitor diagnostics after energization.
- 4 Complete a controlled response and alarm test before service release.
